## Addendum

## Email from Alex Wassman on 3/15/2018 at 11:58 am

The original contract with Olsson was for a maximum of \$149,106.06. With the extension of the schedule that amount will no longer cover the level of service promised through the end of the project. At the time the estimates were provided there was still \$49,585.87 left on the original contract. Olsson estimated that for continued full support they would need a total of \$75,617.25. This means the additional amount requested is \$26,031.38. I did not include the actual estimates as they contain some sensitive information. Sorry if that led to confusion.

The estimates both show Olsson providing support for the whole contract, but the lower estimate would require either the ITS Heartland Board or the project team to cover all the tasks and oversight that they do not have the hours/dollars to complete. This is why the additional funds were requested. The other option would be to use them at the full rate and run out of money at some point around a third of the way through 2021. The period of performance for the MCOMP project itself is through the end of 2022 thanks to FHWA giving us an extension.

The original contract terms with Olsson only take us through April 4, 2018. Regardless of what we decide, I will need to execute an MOU to extend the period of performance on the Olsson contract to utilize the remaining money.

A summary of all of our options are below.

- ITS Heartland could extend the scope, fee, and period of performance of the current grant administration project. Olsson continues providing full services at an additional cost of \$26,031.38, with that pool of money expended in 2021 and 2022.
- ITS Heartland could extend only the scope and period of performance at no additional cost.
  - Olsson provides full services through the beginning of 2021 as estimated. Either the ITS
    Heartland board or one of the member states can provide full oversight, technical
    reviews, required FHWA documentation, etc. after that time. In this case, we are hoping
    that the estimated hours required was high and Olsson would be able to extend their
    services longer than expected.
  - Olsson provides partial services through the end of the contract in 2022. Olsson will not lead all aspects of the project, and either the ITS Heartland board or one of the member states must provide partial oversight, technical reviews, required FHWA documentation, etc. to cover the shortfall.
